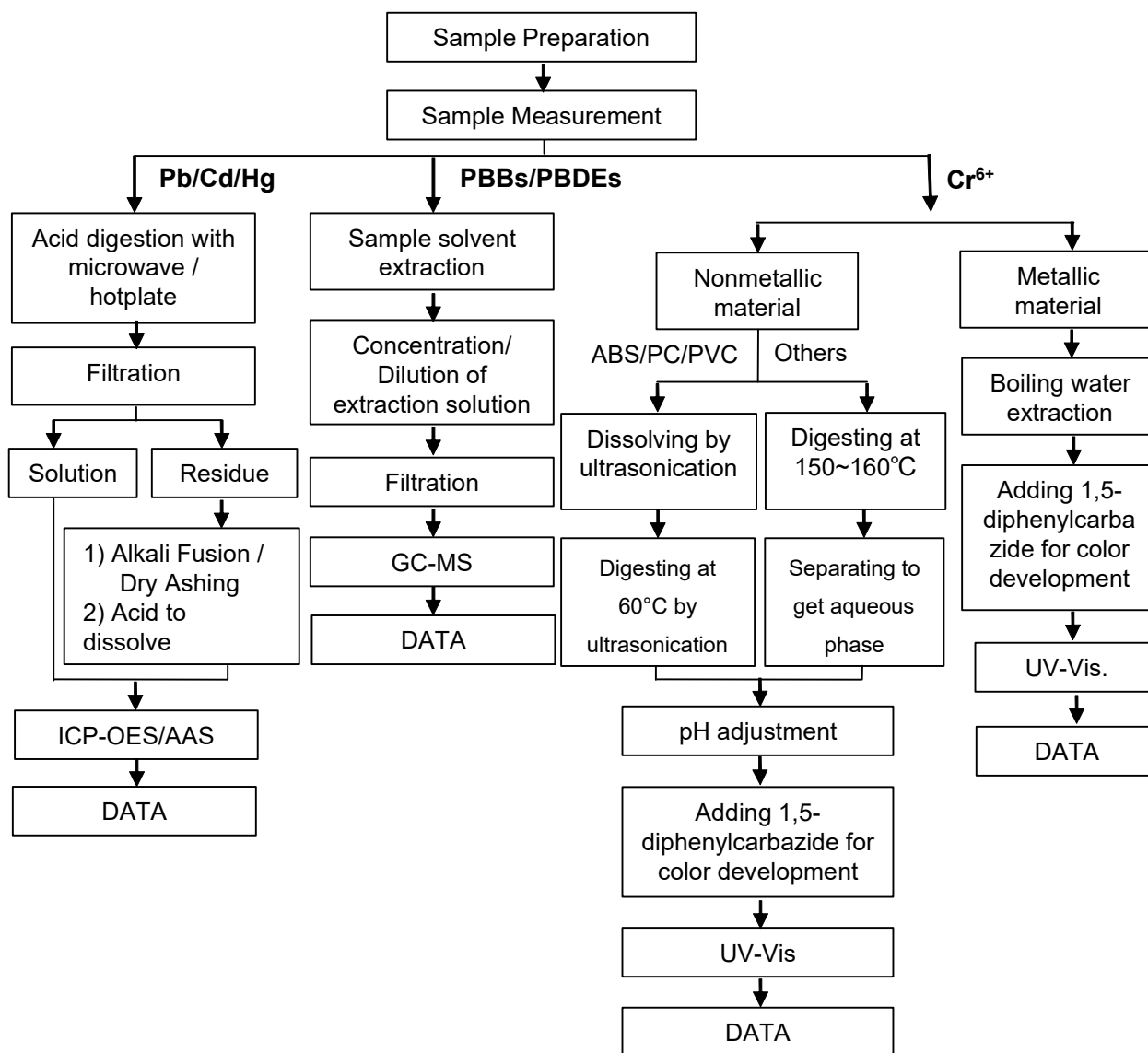

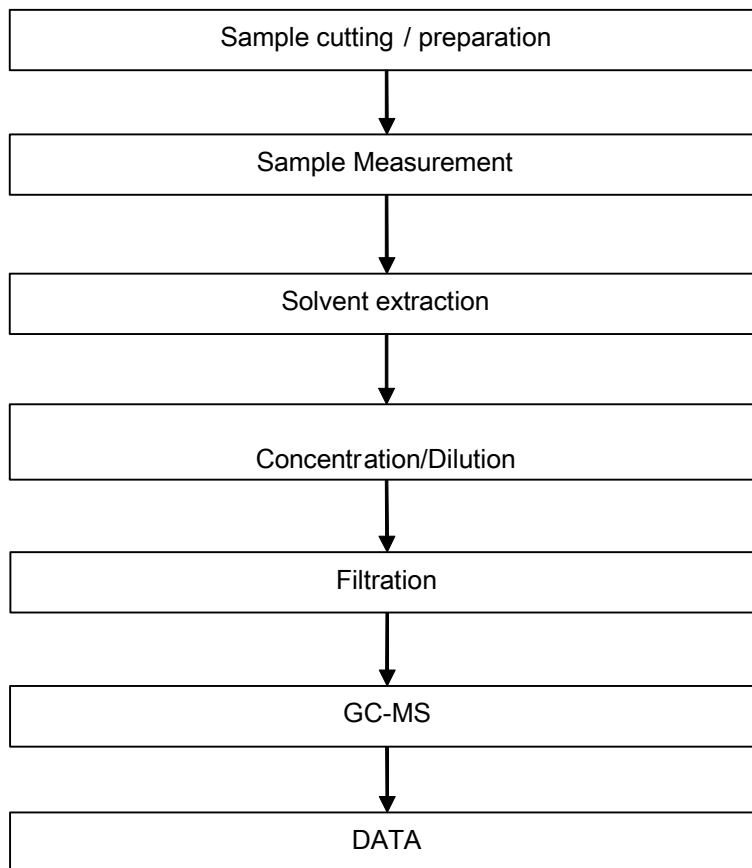

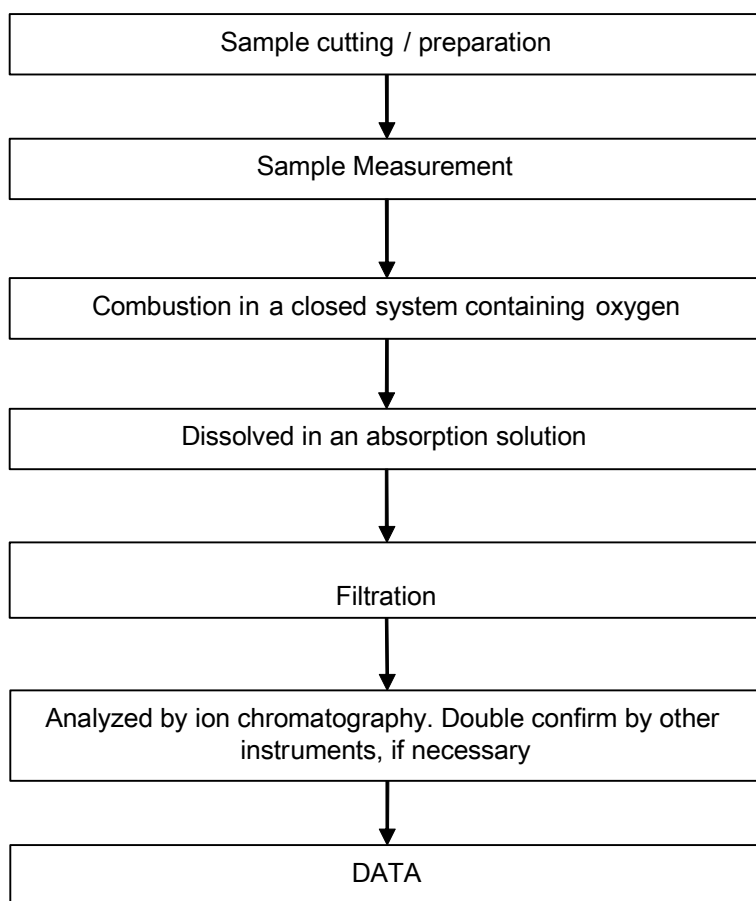

Halogen Testing Flow Chart

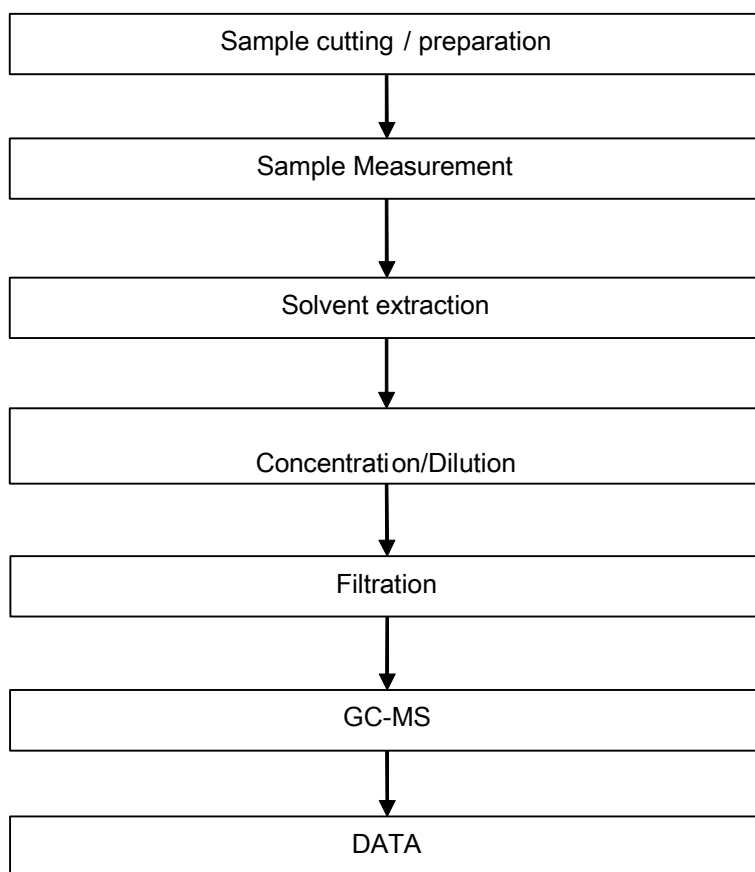

HBCDD Testing Flow Chart

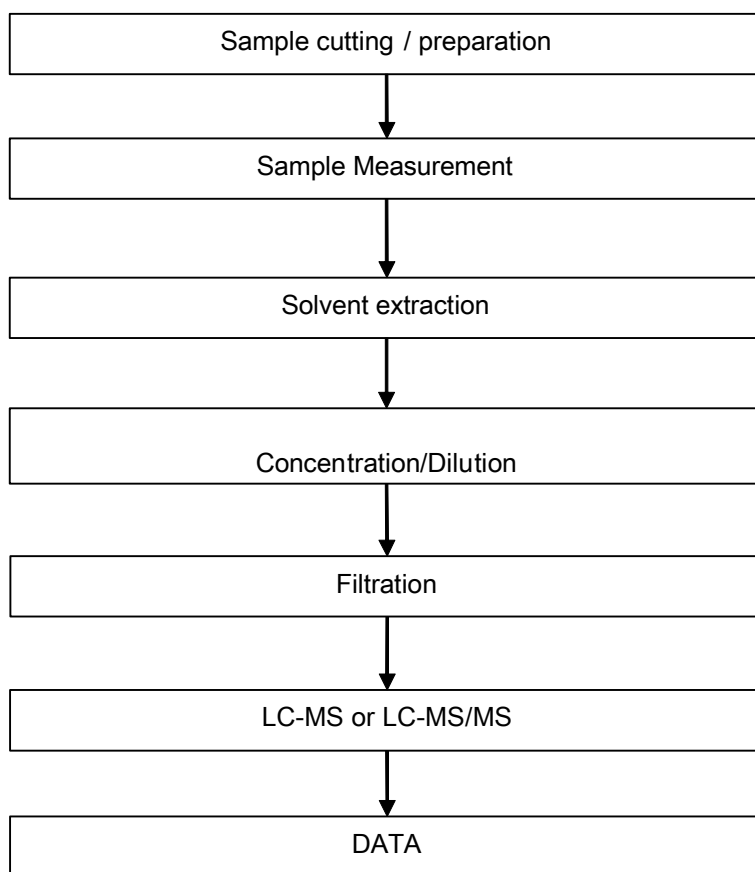

Testing Flow Chart

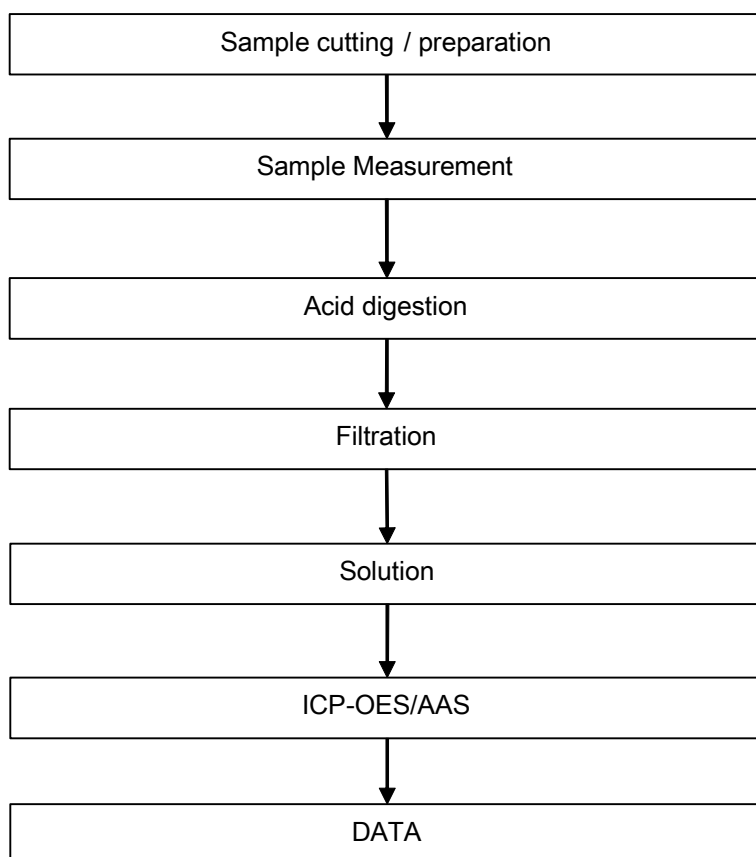

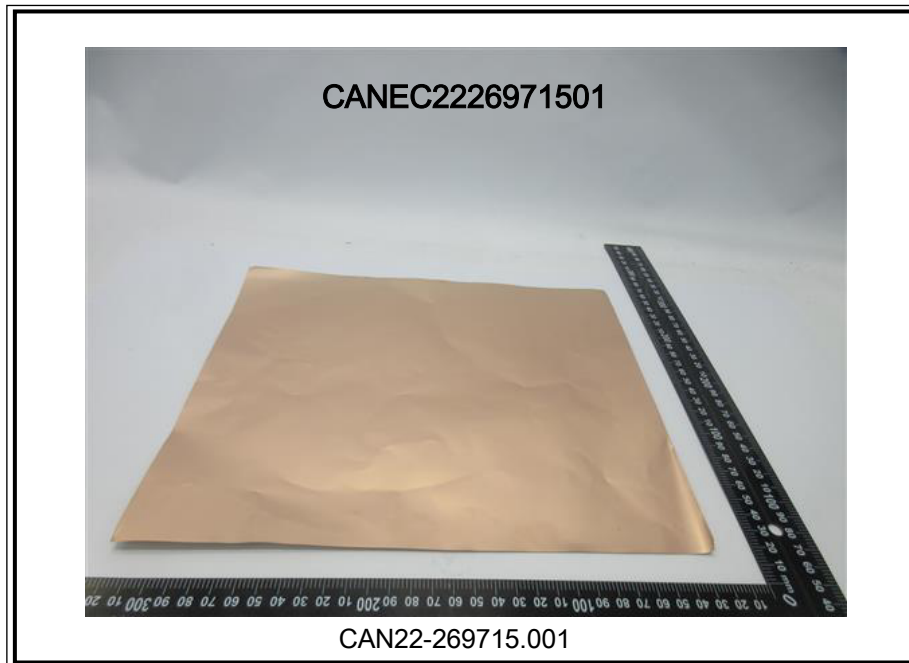
